 - In the case of the receipts & payments accounts of the receipts and payments for the year ended on that date.

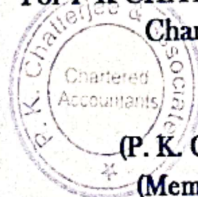

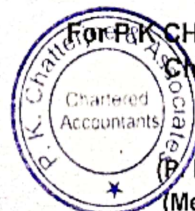
